## **Changing the Language of Addiction**



Terms that stigmatize addiction can affect the perspective and behavior of patients, clients, scientists, and clinicians. Clinicians especially need to be aware of person-first language and avoid more stigmatizing terms.

## Terms Not to Use

- addict, abuser, user, junkie, druggie
- alcoholic, drunk

MICHIGAN STATE

- oxy-addict, meth-head
- ex-addict, former alcoholic
- clean/dirty (drug test)
- addictions, addictive disorders

# **Terms to Use**

- person with a substance use disorder
- person with an alcohol use disorder
- person with an opioid use disorder
- person in recovery
- negative/positive result(s)
- addiction, substance use disorder

#### What Can We Do About Opioid Misuse?

- $\rightarrow$ Store medications safely by locking them up
- $\rightarrow$ Do not share your prescription medications
- $\rightarrow$ Take unused medications to prescription drop-off points or events
- $\rightarrow$ Learn to recognize the signs and symptoms of opioid misuse
- $\rightarrow$ Educate others about addiction as a chronic disease
- $\rightarrow$ Be ambassadors for reducing stigma: addiction  $\neq$  lack of willpower
- $\rightarrow$ Syringe and medical exchange programs
