FY 2023 Budget Discussion/Recommendations:

Christensen suggested as a separate budget item paving the proposed loop trail at Myles Kimmerly Park in an amount not to exceed \$190,000.00 and asking the Board of Commissioners to fund it independently of the Parks and Recreation's normal yearly budget. He said if the County Board funds this project, perhaps local funding sources would contribute as well. Lautner said there may be more American Rescue Plan Act dollars coming from the state and suggested asking for \$200,000.00. Christensen thought the ask should be \$190,000.00. Evans inquired and the group confirmed that paving the loop trail was in the CIP (Capital Improvement Plan).

The group decided to ask for additional dollars for capital outlay for the 2023 budget and was in concurrence to submit the following projects for each of the parks, with all other line items in the budget will remain the same:
