Please take notice that a Regular Meeting and Public Hearing of the Leelanau Township Planning Commission will be held on Thursday, April 8, 2021 at 7:00 p.m. by electronic remote access.

**THIS MEETING IS BY ELECTRONIC REMOTE ACCESS ONLY - SUBSEQUENT TO A LOCAL STATE OF EMERGENCY BEING ISSUED BY THE TOWNSHIP SUPERVISOR.**

The meeting will also include a Public Hearing on a proposed Zoning Ordinance Amendment that would impose a 180-day moratorium on the acceptance of any application for permits for RV Parks and Campgrounds in the Commercial Resort Zoning District in Leelanau Township. The proposed ordinance amendment can be reviewed at <https://www.leelanau.gov/leelanautwp.asp>, or at the Leelanau Township Office during regular office hours.

Persons attending in-person must wear a mask and maintain proper social distancing requirements. The Leelanau Township Hall has limited capacity for attendees.

To provide for orderly public participation, a person wishing to speak must state their name and request to be recognized by the Chairperson. The Chairperson will recognize all persons wishing to speak during public comment.
