# **OLD BUSINESS**

## **NEW BUSINESS**

1- Suttons Bay Township Short Term Rental (STR) Agreement

Presented the current STR document & revised STR Draft to the board. Draft being reviewed by attorney. Discussed parking issue, on or off property, paved area, in right of way. Board should be prepared to discuss revised edition at next meeting

#### 2- County Road Commission Agreement

Tom reviewed the document with the board. Will not sign until \$45,000 in bank and commit the remaining \$15,000 from SB Township as previously agreed.

#### 3- Dog Park

Tom Allen's recommendations will be followed in regards to NO FOOT TRAFFIC ON LARGE DOG PARK UNTIL SPRING 2024. Grass is starting to sprout and needs time to grow & not damaged from early use

Signs can be installed (there are roughly 100)

- · Reaching over fencing from small dog park
- Wait until a good base of snow is covering grass

- Wait until Spring 2024 to enter Large Dog Park
- 4- Zoom- Should Suttons Bay Township continue to offer public viewing of meetings via Zoom? Modify or keep as currently used? Needs someone to monitor guests signed in. Necessary for attorneys, bad weather, public hearing, recording secretary's minutes. Possible options for modifications:
  - Allow comments/interaction
  - View only option
  - Record for accuracy of minutes

Agreed to check with other commissions/boards for their policy and revisit at November meeting
