

Miscellaneous Government Addresses for Notification in Probate Proceedings

ATTORNEY GENERAL ADDRESS – NO KNOWN HEIRS

MCR 5.125(A)(1) requires that the Michigan Attorney General must be served in specific probate proceedings when the decedent is not survived by any known heirs, or the protected individual has no known presumptive heirs. These notices should be sent to the following address:

DEPARTMENT OF VETERANS AFFAIRS (VA) CONSERVATORSHIPS

For conservatorships established under the Uniform Veteran's Guardianship Act, MCL 35.71 et seq., (the individual receives benefits paid by the veteran's administration), a copy of each inventory and annual account must be sent to the VA for review. Copies must be sent to the following address:

MCL 700.5104(2) and MCR 5.125(C)(24) require that a governmental agency paying benefits to the individual to be protected or before which an application for benefits is pending must be served in conservatorship and/or protective order petitions. If the individual is receiving social security benefits, these notices should be sent to the following address:
