HERE IS KONRAD KOHLS VOTER CARD. He hasn't lived in THIS VOTING DISTRICT FOR 10 YEARS. HE also has been dead for 10 years.

you will see his voting card that was mailed to the owners that have own that house for 10 years, his obituary, his grave stone and confirmation online he is registered.

how can someone that has been dead for ten years still be registered to vote? does the clerk need volunteers to help go over registered voters list?

Also I am here to express concern and the need for a handcount of the ballots. To secure our elections and regain the peoples trust.

I went to the Leland Fire Station voting Machine test run on Friday July 15th, 2022 at 1:00 pm

Lisa Brookfield stated to us that this is how they have been doing the testing for years setup by Michelle Crocker.

Lisa informed us motioning to the dominion machine that we get a packet from the vendor to do the testing. (sandyGduring the voting machine test from suttons bay stated the vender is dominion)

SO WE ARE USING DOMINION TO TEST IF THE DOMINION MACHINE IS PROVIDING A FAIR ELECTION COUNT FOR OUR COUNTY.

does our county pay for this testing packet from the vender? Lisa stated that..

In the packet is 38 prefilled ballots. A spread sheet stating what the ballots have VOTED.

What would it take for our county to do it's own ballots to ensure a proper testing instead of Dominion? why would we disinfranchines our own local control of our elections?

Lisa stated we did it this way because Michelle Crocker told her it was to hard to fill out test ballots, along with to much time and money.

According TO THE TEST PROCUDURE MANUAL PAGES 18-39 SHOW what the bare minimum is for the test ballots and no maximum limit to the amount of ballots to test.

It is time for us to start doing our own ballots.

Lisa Brookfield held up a handfull of ballots fanning them out and stated that the circles are prefilled by a printer, pen and sharpie.

I asked her to repeat that and do they also do different color ink. yes printed, blue pen, black pen, and black sharpie.

I have to ask why are we testing ballots with printed filled in votes? No one in this county votes by a printer. I checked The test procedure manual and yes they use printer ink filled voter circles.

printer ink filled voter circles.

Day, you will want to increase the number of ballots ordered for each precinct to be used for this purpose. It is also recommended that all ballots included in the test deck be marked using a black or blue ink pen and that a certain number of test ballots be folded to simulate the tabulation of absent voter ballots.

**NOTE:** If a test deck includes ballots marked by a printer and those ballots did not come from the stock that will be used on Election Day, at least three should be replaced and hand marked with Election Day ballots. This ensures testing of both the program and Election Day ballots.

all the ballots are ran into the machine and yes the printed ballots get counted to.

the voting count tape is printed out.

that tape of the vote count comes out of the Dominion machine and compared to the the dominion spread sheet provided.

the dominion voting machine count tape is never compared to the ballots. the ballots are never checked to match the spread sheet.

We are given by dominion the ballots to run that never get checked and to compare Dominions spread sheet to the dominion voter tape.

This is how we check to make sure the dominion machines do not cheat us from our votes.

Lisa said this is the process we have been doing for years and they just check the sheet with the tape because it's easy and faster.

we never check the ballots. we cannot say we truly certified that the dominion voting machine because we never see if the votes on the ballots match the count.

Our County and our clerks are not protected by the process of certification. Our own machines are not even kept under loc and key and left in a room at the firestation where anyone could get access to it.

A HAND COUNT OF PAPER BALLOTS DURING ELECTION IS THE ONLY WAY TO GO TO KNOW THAT ALL OUR LEGAL VOTES ARE COUNTED.
