Meeting called to order at 3:01 p.m. by Chairman William Bunek. Today's meeting is being held at the Government Center, 8527 Government Center Drive, Suttons Bay, Michigan.

Administrator Janik wished Commissioner Lautner Happy Birthday and presented her with a cake.

Purpose of Meeting - Discussion/Potential Action -

Continuation of Review of American Rescue Plan Act (ARPA) Funding Requests:

Administrator Janik stated a spreadsheet will be available later in this meeting from Finance Director Jennifer Zywicki showing what has been spent out of the ARPA funds already and what is left that they can allocate. Janik suggested giving the presentations and have the discussion after that to have the bigger picture.

Leelanau County Housing Initiatives/Potential ARPA or Other Funding -

Yarrow Brown, Housing North:

Yarrow Brown with Housing North was present before Commissioners and spoke regarding the purpose of Housing North and said today they are formally asking for support for a contract for services with Housing North to provide technical support that would help remove barriers to housing and support the housing needs of Leelanau County and its residents. Brown said they are asking for \$20,000.00 for this year with ability to renew for an additional two years.

Brown answered questions from Commissioners and brief discussion ensued.

Trudy Galla, Director, Leelanau County Planning/Community Development:

Director, Leelanau County Planning/Community Development Trudy Galla was present to talk about housing and funds. There are several requests before Commissioners for the use of ARPA funds for housing including requests from Housing North, Habitat for Humanity, Leelanau Christian Neighbors, and the Housing Action Committee. Galla continued by saying currently with housing funds through her department they have an agreement with Northwest Community Action Agency which will expire at the end of June, and whatever funds that are left have to go back to the State as a requirement. June 15, 2021, the Leelanau County Board of Commissioners passed Resolution #21-009 and it was with Habitat for Humanity for a \$60,000.00 partnership to assist them to acquire back a home where they had the first right of refusal to keep it within affordability restrictions and get the next eligible homeowner into that property. Galla stated that has not occurred as the person was not able to find other housing and have stayed in that house so the first right of refusal has not been exercised and the \$60,000.00 has not been used.

Galla stated to Commissioners that she is basing her suggestions to them off of what she has heard from the presentations on housing, the requests to the Board, as well as what she still has available in housing funds. Galla gave the following suggestions for consideration and gave a brief explanation for each:

- Support the Leelanau Christian Neighbor Rehab Program with ARPA funds;
- Support for Habitat for Humanity's project in Maple City, Michigan;
- Support Housing North with their 3-year request by committing \$12,000.00/year.

Galla answered Commissioners' questions.

Wendy Irvin, Habitat For Humanity:

Wendy Irvin, Chief Executive Officer of Habitat for Humanity Grand Traverse Region was present along with Angela Skeans, Director of Operations and Director of Development Jesse Wolff to discuss the 'Shovel Ready Projects' in Leelanau County. Irvin, Skeans, and Wolff responded to questions from Commissioners.

Points Communication Contract Update:

Director of Emergency Management Matt Ansorge was present to update Commissioners on the proposed Government Center campus communications tower. Ansorge stated that Midway Electronics has agreed to the terms of the contract of \$435,650.00 with the bonds included in the contract. Administrator Janik added that Midway has signed the contract and if approved at the Regular Session meeting Chairman Bunek can sign the contract this evening.

Janik also offered an update on the Leelanau Township Tower and said they had a very productive meeting with Cherryland Electric this morning and Cherryland has authorized to share the news that they are very interested in forming a partnership with us. That could be a financial partnership to provide a tower in that area and they have been looking at sites. Ansorge will go

forward with doing the studies and finding a location and they will update their board maybe next week. A very good dialogue was had.

Ansorge and Janik answered questions from Commissioners.

Fund Development Partnership Proposal:

Administrator Janik said this item ties in with February discussion they had as a Board and as well as various ARPA funding. Janik added that it had been discussed how they could get additional funding and everyone thought it may be a good idea to bring in a professional consultant or grant writer. There is at least at least \$5.4 or as much as \$8 billion in Michigan alone that has to be allocated, so we are looking at how to access that. Janik said this is a sample agreement today to look at between Leelanau County and Venture North. The handout can be viewed at the link below (pages 2-5):

Janik continued and said Venture North would be involved in helping to secure another \$4.8 million dollars for projects. It is on a very specific deadline to get this done by October 31, 2022, and the cost would be to not exceed \$80,000.00. The consultant is Tim Irwin who has a proven track record of being successful for many organizations.

Commissioner Soutas-Little spoke and said they are looking at two composite projects, one to be the balance of \$1.8 million which would complete the Point Broadband contract. The other is to address the four townships that do not have a way to serve the communities which would include Empire, Kasson, Glen Arbor, and Cleveland. This additional roughly \$3 million would be to bring fiber into those particular townships. Soutas-Little added they have been in touch with some of the internet service providers (ISPs) talking about this and getting some numbers and how that would work.

Commissioner discussion ensued.

Lower-Level Renovations Update/Options:

Environmental Health Director Eric Johnston and Director of Administrative Services Dodie Putney of the Benzie-Leelanau District Health Department were present before Commissioners and Administrator Janik stated that having had conversations regarding the possibility of housing the health department in the lower level of the Governmental Center they are now at a point where a decision needs to be made to move forward or not. Johnston told Commissioners it would be his division that would be moving downstairs if approved.

Janik said after a follow-up meeting with John Richards of Apollo Engineering LLC. for more details he was provided a sample contract showing a cost to come up with the engineering specs would be about \$5,000.00, and the cost to complete the project would be about \$489,000.00 based on current prices. Janik said to move forward the Board would need to allocate \$5,000.00 to do the drawings. Johnston indicated that after looking at the areas in the lower level with County Maintenance Director Jerry Culman II, the "Ugly Room" is too small but the exercise room/storage room area would be more adequate. Discussion between Commissioners, Johnston, Putney, and Janik continued regarding the Benzie-Leelanau District Health Departments current building lease, construction of the new office space and size, and options of necessary additional storage for this building if the exercise/storage room was converted.

MOTION BY BUNEK TO MOVE FORWARD WITH THE CREATION OF THE ARCHITECTURAL DRAWINGS FOR THE NEW HEALTH DEPARTMENT OFFICE SPACE IN THE LOWER-LEVEL OF THE GOVERNMENT CENTER BUILDING. SECONDED BY ROBBINS.

Commissioner Wessell stated he thought they were going to wait on taking action.

Motion withdrawn by Bunek. Okay with the second.

Break taken at 4:30 p.m. and the meeting resumed at 4:41 p.m.

Zywicki said the ARPA funding will come in at \$4.2 million, the broadband that there is a motion on the books for is \$3.2 million, an accepted housing proposal for \$125,000.00, and the broadband study was \$59,000.00 that was all allocated last year. Available funds after the projects already approved is \$816,000.00.

Commissioner Lautner questioned Zywicki regarding the funds that they have committed to vs. the available funds shown. Zywicki responded and then reviewed the L-4029 revised Operating Millage Approval Dates and General Fund Budgeted Tax Revenue vs Proposed Actual spreadsheets. Zywicki added that there is fund balance to pull from, revenue can be generated at the maximum levy in May to help offset additional costs, as well as what had been talked about with the Treasurer with the DTR (Delinquent Tax Revolving fund) and money there also.
