CENTERVILLE TOWNSHIP FIRE AND AMBULANCE MILLAGE PROPOSITION

Shall the limitation on the total amount of taxes which may be levied against all properties in the Township of Centerville, Leelanau County, Michigan, for all purposes be increased as provided by section 6, Article 9 of Michigan Constitution by an amount not to exceed 1.25 mills (\$1.25 per thousand dollars of taxable value) as established by the State of Michigan on all properties in Centerville Township for a period of two years (2018 and 2019) to be used for equipment and operation of the fire and ambulance departments within the Township, and shall the Township levy such increase in millage for such purpose(s) during such period which will raise in the year 2018 an estimated \$129,900.00 and in the year 2019 an estimated \$129,900.00?
