

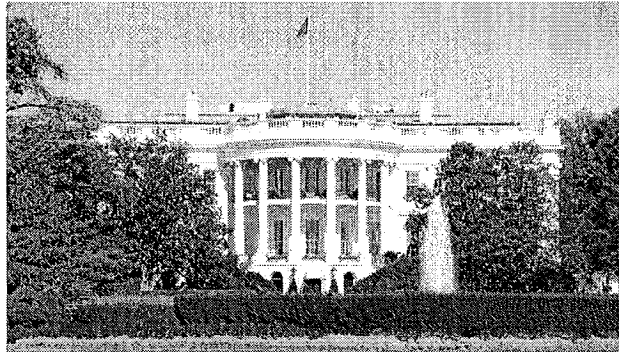

Commissioners who decide to attend a special White House briefing on Oct. 3 for county leaders from our state, Kentucky and Ohio will have a full day of activities in Washington, D.C., as MAC and the National Association of Counties have finished details on additional events.

NACo will host a federal policy briefing in partnership at 8:30 a.m. at NACo headquarters, 660 N. Capitol St. NW. A light breakfast will be provided.

At approximately 9:30 a.m., attendees who also have signed up for a tour of the White House's East Wing, can take a cab/Uber to the White House.

Attendees will have lunch on their own before the White House briefing begins at 1 p.m.

For lodging, NACo suggests the Washington Court Hotel and Phoenix Park Hotel.

The Oct. 3 session for county officials from Michigan, Kentucky and Ohio will be the ninth such session in a series "designed for county (commissioners/supervisors) and municipal officials and will include briefings and discussion with senior administration officials on shared federal-state-local priorities pertinent to your respective states." The session will run from 1 p.m. to 4:30 p.m.

Commissioners have until 1 p.m. on Friday, Sept. 27 to RSVP for the event. Space is limited. RSVPs will be honored in the order they are received, the White House said.

It is essential that all information is submitted accurately, the White House added. The information you submit must exactly match what is listed on your government issued identification that you will be required to present to Secret Service before entry to the White House grounds.

The session builds off a 2017 event that drew more than 50 Michigan county leaders to the White House.

The day also will offer an East Wing tour, with separate reservations. **Information on that event will be released in late September.**

"This event just continues what has been sustained and effective outreach from this White House to county leaders in Michigan and elsewhere," said MAC Executive Director Stephan Currie. "We look forward to again sending a large delegation to Washington for what I am sure will be fruitful discussions on a variety of federal topics."
