**PRESENT:** James Schwantes, Ron Schaub, Elizabeth Chiles, Dan Hubbell; **ABSENT:** Trina Pleva

**GUESTS:** 2 members of the public present

1. **Call to Order:** Supervisor Schwantes called the meeting to order at 11:58 AM
2. **Review /Amend / Approve Agenda**
  1. **Agenda—no changes**

**MOTION:** Hubbell moved to approve agenda as submitted; seconded by Chiles. Motion carried.

3. **Treasurer's Report as of February 28, 2023, Balance Sheet as of March 15, 2023, and FYI 2022-23 Budget and Expenditures**—The Treasurer's report was previously reviewed and accepted at the February 2023 Township Board meeting.
  1. Supervisor Schwantes noted that we currently have >\$600,000 in balance, which includes receivables. The 2023-24 budget reflects an accumulation of ~\$200,000 in fire millage fund and approximately \$100,000 in remaining ARPA funds. In addition, there are currently ~\$144,000 in unassigned funds.
4. **Amend FY 2022-23 Budget if needed**—no amendments
5. **Public Hearing on Proposed Township Budget for Fiscal Year 2023-24**
  1. Open Public Hearing opened at 12:06 PM
  2. Take Public Input—Dar Doorlag asked whether there was funding in the budget for the 2023 construction of LLLA boat launch. Supervisor Schwantes indicated that there was not currently, but that funds could possibly be moved to cover some of the boat launch expenses later in 2023, given our existing budget. There is currently \$35,000 of net revenue in the budget that has not been assigned.
